

AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A CONTRACT FOR THE PURCHASE OF EQUIPMENT FOR THE CITY SERVICES DIVISION OF THE CITY OF ASHLAND, OHIO, OBTAINING FORMAL ADVERTISING AND BIDDING; AND DECLARING AN EMERGENCY.

WHEREAS, this Council deems it necessary and advisable to immediately purchase equipment for the City Services Division of the City of Ashland, Ohio; and,

WHEREAS, this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, property, health, safety and welfare and for the further reason that the equipment herein specified is immediately needed in order to provide for the continued efficient and effective operation of the City Service Division of said City of Ashland, Ohio; now therefore,

BE IT ORDAINED by the Council of the City of Ashland, State of Ohio, 5 members thereto concurring:

Section 1. That the Mayor be, and he is hereby, authorized and directed to enter into a contract for the purchase of the following equipment for the City Services Division of the City of Ashland, Ohio, obviating formal advertising and bidding, due to the purchase being through the existing State Cooperative purchasing agreement contract, or per House Bill 204,

Description of equipment:

One (1) New 2014 L225 Cab HVAC Skid Loader.

STS number 800238, Index number STS515

Pricing quoted is less than STS pricing:

Section 2. That the money for said equipment be paid from Account No. 202-1004-53013.

Section 3. That for the reason that the equipment herein specified is immediately needed in order to provide for the continued efficient and effective operation of the Arborist Department of the City of Ashland, this Ordinance is hereby declared to be an emergency measure immediately needed for the preservation of the public peace, property, safety and welfare of said City of Ashland, Ohio.

Section 4. This Ordinance shall take effect and be in force from and after its passage by Council and approval pursuant to Section 12 of the Charter of the City of Ashland, Ohio.
