

ORDINANCE NO. 75-14

AN ORDINANCE TO APPROVE AND ADOPT CURENT REPLACEMENT PAGES TO THE CODIFIED ORDINANCES, AND DECLARING AN EMERGENCY.

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and

WHEREAS, Council has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is before Council, now therefore,

BE IT ORDAINED by the Council of the City of Ashland, Ohio, 5 members thereto concurring:

Section 1. That the ordinances of the City of Ashland, Ohio, of a general and permanent nature, as revised, rearranged and consolidated into component codes, titles, chapters, and sections within the 2014 Replacement Pages to the Codified Ordinances are hereby approved and adopted.

That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety and for the further reason that there exists an imperative necessity for the earliest publication and distribution of the current Replacement Pages to the officials and residents of the City of Ashland, so as to facilitate administration, daily operation and avoid practical and legal entanglements.
