

ORDINANCE NO. 8-16

**AN ORDINANCE AUTHORIZING THE MAYOR AS SERVICE SAFETY DIRECTOR TO ENTER INTO AN AGREEMENT TO PURCHASE A TRACTOR FROM ASHLAND TRACTOR SALES AND TRADE IN A USED TRACTOR. AND DECLARING AN EMERGENCY.**

**WHEREAS**, The Street Division is in need of purchasing a new tractor; and

**WHEREAS**, as a majority of the intended purchase price of the new tractor will be taken from the trading in of the old tractor; and

**WHEREAS**, the old tractor has a current value of more than Five Thousand dollars requiring Ashland City Council's authorization of the trading in of the old unit, now therefore,

**Be It Ordained**, by the Council of the City of Ashland, State of Ohio, 5 members thereto concurring:


**Section 1.** That the Mayor serving in his capacity as Service Safety Director hereby is authorized to enter into an agreement to purchase a new tractor for the Service Division and by doing so trading in the old tractor.

**Section 2.** That in order to meet the immediate financial needs of the City of Ashland, Ohio this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, property, health and welfare of said City of Ashland, Ohio.

**Section 3.** That this Ordinance shall take effect and be in force from and after its passage by Council and approval pursuant to Section 12 of the Charter of the City of Ashland, Ohio.


