

RESOLUTION 21-15

A RESOLUTION AUTHORIZING THE SUBMITTAL OF THE AUGUST, 2015 UPDATE PROPOSAL WITH THE OHIO DEPARTMENT OF TRANSPORTATION FOR GRANTS THROUGH THE US DOT FEDERAL TRANSIT ADMINISTRATION (FTA) AS AUTHORIZED UNDER FEDERAL TRANSIT LAWS, AS CODIFIED, 49 USC SECTION 5311, FINANCIAL ASSISTANCE FOR OTHER THAN URBANIZED AREAS AND FUNDS AVAILABLE FROM THE OHIO PUBLIC TRANSPORTATION GRANT PROGRAM AND EXECUTING AN UPDATED BUDGET WITH THE OHIO DEPARTMENT OF TRANSPORTATION

WHEREAS, the Director of the Ohio Department of Transportation is authorized to make grants for a public transportation program; and

WHEREAS, the contract for financial assistance will impose certain obligations upon the proposer, including the provision by it of the local share of the project costs in the program; and

WHEREAS, it is required by the U.S. Department of Transportation in accordance with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of a proposal for assistance under 49 USC Section 5311 the proposer give an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder; and

WHEREAS, it is the goal of the Proposer that disadvantaged business enterprise be used to the fullest extent possible in connection with this/these project(s), and that definite procedures shall be established and administered to ensure that disadvantaged businesses shall have the maximum construction contracts, supplies, equipment contracts, or consultant and other services; now therefore, .

BE IT RESOLVED by the Council of the City of Ashland, State of Ohio. 5 members thereto concurring:

Section 1. That the Mayor of The City of Ashland is authorized to execute and submit (a) an August Update for the 2015 Budget proposal(s) on behalf of City of Ashland/ Ashland Public Transit with the Ohio Department of Transportation to aid in the financing of capital and operating assistance projects pursuant to 49 USC Section 5311 and the Ohio Public Transportation Grant Program.

Section 2. That the Mayor of The City of Ashland is authorized to execute and file with such proposal an assurance or any other document required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964.

Section 3. That the Mayor of The City of Ashland is authorized to furnish such additional information as the Ohio Department of Transportation may require in connection with the


proposal for the program of projects submitted to FTA.

Section 4. That the Mayor of The City of Ashland is authorized to set forth and execute affirmative disadvantaged business policies in connection to any procurement made as part of the project.

Section 5. That the Mayor of The City of Ashland is authorized to execute grant agreements on behalf of The City of Ashland/Ashland Public Transit with the Ohio Department of Transportation for aid in the financing of operating and capital assistance projects.

Section 6. That this Resolution shall take effect and be in force from and after its passage by Council and approval pursuant to Section 12 of the Charter of the City of Ashland, Ohio.
